NC Medicaid Managed Care Behavioral Health and I/DD Tailored Plan Launches **December 1, 2022**

North Carolina will launch the NC Medicaid Managed Care Behavioral Health and Intellectual/Developmental Disabilities Tailored Plan on December 1, 2022. This is a health plan for individuals with significant behavioral health needs and intellectual/developmental disabilities (I/DDs). The Behavioral Health I/DD Tailored Plan will also serve other special populations.

Who qualifies for a Tailored Plan?

- People who get Innovations Waiver services
- People who get Traumatic Brain Injury (TBI) Waiver services
- People who may have a mental



Community Alternatives Program for Children (CAP/C) and Community Alternatives **Program for Disabled Adults** (CAP/DA) COVID-19 Transition Plan Volunteer Request

In March 2020, NC Medicaid temporarily changed how the Community Alternatives Program for Children (CAP/C) and Disabled Adults (CAP/DA) Home- and Community-Based Services (HCBS) waivers would be carried out during the COVID-19 public health emergency.

The CAP unit within NC Medicaid is seeking volunteers to assist with creating a plan for safer service delivery through the CAP waivers that will reduce risks from highly contagious viruses such as COVID-19. Volunteers will participate in meetings that will focus on the policies created to manage the public health emergency that began in March 2020. The time commitment for these meetings

Children Ages 6 Months and Older are Now Eligible to Receive the COVID-19 Vaccine

Children ages 6 months and older can now receive a COVID-19 vaccine. The Centers for Disease Control and Prevention (CDC) recommends all children who are eligible receive a COVID-19 vaccine. These vaccines were tested and reviewed by the Food and Drug Administration (FDA) and the CDC and their independent scientific committees to ensure they are safe for children. Children ages 6 months to younger than 5 get a smaller vaccine dose than any other age group.

Everyone ages 6 months and older can receive a free COVID-19 vaccine, even

if they don't have health insurance and regardless of their citizenship or immigration status. All children and adults 6 months and older can receive a free COVID-19 vaccine, even if they don't have health insurance and regardless of their immigration status. Parents and guardians with questions about COVID-19 vaccines should talk with their child's doctor. Parents and guardians can also visit MySpot.nc.gov (link) to search for a nearby vaccine provider and find additional information.

The Americans with Disabilities Act Turns 32 This Year!

What is the Americans with Disabilities Act (ADA)?

The Americans with Disabilities Act (ADA) is a civil rights law that prohibits discrimination against individuals with disabilities in all areas of public life, including jobs, schools, transportation, and all public and private places that are open to the general public. This law was passed in 1990 and helps to make sure that people with disabilities have the same rights and opportunities as everyone else. The ADA gives civil rights protections to individuals with disabilities similar to those provided to individuals on the basis of race, color, sex, national origin, age, and religion. It guarantees equal opportunity for individuals with disabilities in public accommodations, employment, transportation, state and local government services, and telecommunications. The ADA is divided into five titles (or sections) that relate to

different areas of public life.
